AE Expansion: The OMHA guidelines are that the major team must be filled BEFORE the minor team. The tryout numbers were reviewed:

Major Bantam:	12 players and 1 goalie
Minor Bantam:	22 players and 4 goalies
Minor PeeWee:	15 players and 2 goalies
Major PeeWee:	23 players and 2 goalies
Major Atom:	8 players and 2 goalies
Minor Atom:	25 players and 2 goalies

The PeeWee fits the criteria and there has been a Minor PeeWee team the last two years. A motion was put forward to proceed with Major and Minor Bantam; Major and Minor PeeWee teams; with the clear understanding that each team will consist off:

Major Bantam = 15 players plus 2 goalies

Minor Bantam, Minor PeeWee and Major PeeWee = 14 players plus 2 goalies.
